2. If you doubt the quantity of gas in the cylinder, please insist on having it weighed before accepting the delivery.
3. Get the installation checked/serviced only by our authorized mechanic and not by deliveryman or an outsider.
4. Insist on a cash memo if any amount is paid.
5. Extinguish all open flames, while changing the cylinder or servicing the appliances.
6. For your family's safety use Bharatgas Suraksha Hose and replace your Suraksha hose in every 5 years.
7. Switch off the regulator when not in use.
8. In case of any accident involving LPG installation, customer must intimate Bharatgas distributor immediately. We have taken PLI Policy to cover loss of life/property and medical expense in case of accident caused primarily by leakage of LPG at registered premises.
9. Please do not hand over your empty or leak cylinder to anyone without on-the-spot replacement with a full cylinder.
10. If you smell LPG Switch off the regulator. Do not switch ON/OFF any electrical equipment, as it may cause spark. Please contact 1906.
11. M.R.T.P Notification: While you are welcome to purchase cooking appliances or other products available with us, we would like to make it clear that it is not obligatory for you to purchase the same from us. You are at liberty to buy cooking appliances or other products
